The theme of the conference

The Temporalities of Mosaics: Representation, Implementation, Perception, Conservation-Restauration

Temporality refers to any form of relationship to time. Questioning the *temporalities* of mosaic means engaging with the multiple dimensions of experience implied by this medium — iconographic, technical, economic, phenomenological, historiographic, or heritage-related.

From a **material perspective**, time intervenes from the very outset of the production process. The procurement and preparation of materials, culminating in the laying of the mosaic, may be considered as successive stages that shape the experience of all participants, from patron and designer to artisan. Equally, processes of wear, maintenance, and renovation mark the life of mosaics, inscribing them within both the passage of time and the rhythms of human activity.

Understanding the **use and perception** of a décor over time requires consideration of its role within the built environment. How is time signified in **iconography** – through measuring instruments, personifications and divinities, seasonal activities or products – and to what purpose? Do images participate in, or even structure, the temporality of human activities unfolding within the room or building? At the level of the décor itself, reflection will also extend to the association of forms and styles from different periods, or the integration of earlier mosaics into new contexts. Attention will further be given to the permanence, or conversely, the transformation of mosaic decoration in

relation to changes in ownership, architectural frameworks, or the intended function of spaces.

Finally, the discussion will encompass **post-antique treatments** of mosaics. *Spolia*, destruction, and the reuse of materials all bear witness to the plurality of relationships with the ancient past – at times valorised, (re)negated, or ignored. Modern restorations also belong to the life of these décors: themselves marked by the passage of time they seek to counteract, they inevitably involve choices as to what should or should not be (de)restored. Temporality likewise lies at the heart of museographic discourse, which governs the modes of presentation of mosaics – whether organised according to chronological, anachronistic, or transhistorical logics. An historiographic approach, in turn, can shed light on the construction of modern knowledge of the mosaic, showing how sources, methods, and research questions evolve across time, conditioning our own perception.

Exploring the temporalities of mosaic thus places in dialogue past and present perspectives, as well as the interplay of décor, space, and human actors over time. Such an approach calls upon complementary disciplines – archaeology, history, art history, but also anthropology and semiotics – while integrating archaeometric data and engaging with contemporary debates in cultural mediation and museology.

Papers and posters

Proposals for papers and posters must fall under one of the two following themes:

Theme 1 – The Temporalities of Mosaics: Representation, Implementation, Perception, Conservation-Restauration

Presentations will present excavation, site-scale, regional or provincial syntheses. Each presentation will last 20 minutes.

Theme 2 – New Discoveries and New Interpretations

This theme will include 20-minute presentations dedicated to original research and studies that do not fall under Theme 1.

The conference will be held in person. No presentation in videoconference will be accepted. At least one presenter (for both papers and posters) must be physically present. All presenters attending the conference are required to pay the full registration fee.

Posters must be printed by their authors in accordance with the formatting guidelines that will be provided at a later date.

Submission

Proposals must include the title and abstract of the presentation, the authors' full names, affiliations, and contact details (postal and email addresses, phone number). It should also be specified whether the submission is for a paper or a poster, in Theme 1 or Theme 2. Abstracts (**up to 3,000 characters**, in .doc format) may be supplemented with any additional supporting documents deemed relevant.

The scientific committee will select the proposals that will be presented during the conference and will notify the authors in early December 2026.

Papers and posters will be published in the Conference Proceedings. The deadline for their submission is **January 31, 2028**.

Registration will be open from December 15, 2026, to August 15, 2027.
